## To: People interested in the Kootenai National Wildlife Refuge Floodplain Reconnection Project

Bonneville Power Administration (BPA) has finalized the Environmental Assessment (EA) for the Kootenai National Wildlife Refuge Floodplain Reconnection Project (Project). Based on the final EA, BPA is issuing a Finding of No Significant Impact (FONSI) and has made a decision to proceed with the project. This letter describes BPA's decision, the construction schedule, and how to obtain additional information.

**Background:** BPA proposes to provide funding to the Kootenai Tribe of Idaho (KTOI) to restore floodplain connectivity to the Kootenai River historic floodplains within the Kootenai National Wildlife Refuge (KNWR) in Boundary County, Idaho near Bonners Ferry, Idaho. The KNWR is managed by the U.S. Fish and Wildlife Service (USFWS). The USFWS and the KTOI are the project sponsors. The project's reconnection activities would include breaching levees, raising roads, replacing water control structures, enhancing wetlands, and re-establishing wetland connections.

BPA prepared an EA to help the agency determine if the project would cause significant impacts that would warrant preparing an environmental impact statement under the National Environmental Policy Act. BPA released the draft EA for public review and comment in September 2024 and received comments from five individuals and three entities. The final EA provides responses to those comments and minor revisions to the EA. Based on the EA analysis and mitigation measures included in the EA and Mitigation Action Plan to help lessen impacts, BPA has found that the project will not cause any significant impacts and, therefore, an environmental impact statement will not be prepared.

**Decision:** BPA has decided to fund KTOI for construction of the Kootenai National Wildlife Refuge Floodplain Reconnection Project. Project construction is expected to begin in Summer 2025 and continue for two calendar years, with breaks in construction during seasonal restrictions.
