Categorical Exclusion Applied (from Subpart D, 10 C.F.R. Part 1021): B1.25 Real property transfers for cultural resources protection, habitat preservation, and wildlife management

Description of the Proposed Action: BPA is proposing to fund the Kootenai Tribe of Idaho (KTOI) to purchase the Tuin Road property, a 164-acre parcel of land located roughly 9 miles northeast of Bonners Ferry, Idaho. BPA would hold a conservation easement to permanently protect, mitigate, and enhance fish and wildlife and their habitat.

Funding the purchase of the property would support ongoing efforts to mitigate for the effects of the Federal Columbia River Power System on fish and wildlife in the mainstem of the Columbia River and its tributaries pursuant to the Pacific Northwest Electric Power and Planning and Conservation Act of 1980 (the Northwest Power Act) (16 U.S.C. 839 et seq.).

The property consists largely of upland forest dominated by Douglas fir (*Pseudotsuga menziesii*) and ponderosa pine (*Pinus ponderosa*) trees, ideal habitat for flammulated owl (*Psilosops flammeolus*), a Tribal species-of-concern. The property would be incorporated into KTOI's portfolio of mitigation areas in northwestern Idaho. KTOI would develop a land management plan to guide the protection and enhancement of habitat and other resources on the property. The land management plan would be drafted within 18 months of closing. The management plan would be reviewed by BPA for consistency with the conservation easement and the purpose of the acquisition. If BPA proposes to fund any additional activities on the property, further environmental review may be conducted.

Findings: In accordance with Section 1021.410(b) of the Department of Energy's (DOE) National Environmental Policy Act (NEPA) Regulations (57 FR 15144, Apr. 24, 1992, as amended at 61 FR 36221-36243, Jul. 9, 1996; 61 FR 64608, Dec. 6, 1996, 76 FR 63764, Nov. 14, 2011), BPA has determined that the proposed action:

- 1) fits within a class of actions listed in Appendix B of 10 CFR 1021, Subpart D (see attached Environmental Checklist);
- 2) does not present any extraordinary circumstances that may affect the significance of the environmental effects of the proposal; and
- 3) has not been segmented to meet the definition of a categorical exclusion.

Based on these determinations, BPA finds that the proposed action is categorically excluded from further NEPA review.¹

Proposed Action: Tuin Road Land Acquisition

Project Site Description

The Tuin Road property is a 164-acre parcel of land located in rural Boundary County, Idaho. The majority of the property consists of rolling hillsides dominated by upland forests of Douglas fir and ponderosa pine. The Moyie River runs through the western edge of the property, with a limited riparian forest corridor along its banks. Flammulated owl is a small migratory owl which spends its summer nesting season in northern Idaho and southern British Columbia before migrating south to Mexico during winters. The owl nests exclusively in multistory coniferous forests such as those found on the Tuin Road property, and conservation of the property would help protect this vital nesting habitat in perpetuity.
