The Bonneville Power Administration (BPA) has received your request for agency records made under the Freedom of Information Act, 5 U.S.C. § 552 (FOIA). BPA received your records request on April 2, 2021, and assigned your request a tracking number of BPA-2021-00608-F. Please use that tracking number in any correspondence with the agency regarding your FOIA request.

Request

"...a complete list of current salary, employment hire date, employment end date (if applicable), current GS Level, current GS Step, and name of employee for all Bonneville Power Administration (BPA) employees with the Job Title "Contract Specialist" employed between January 1, 2020 and present (April 20, 2021)."

Acknowledgement

BPA has reviewed your request and determined that it fulfills all criteria of a proper request under the FOIA and Department of Energy regulations at Title 10, C.F.R., Part 1004 (for FOIA).

Response

Knowledgeable agency personnel collected one page of responsive records from the Human Resources Management Information System (HRMIS) database. That single page accompanies this communication with redactions applied under 5 U.S.C. § 552(b)(6) (Exemption 6). A more detailed explanation of the applied exemption follows below. The word "termination" in the record reflects the employee's last day at BPA. "Termination" refers to the end of employment for any reason, including voluntary departure and retirement.

Explanation of Exemptions

The FOIA generally requires the release of all agency records upon request. However, the FOIA permits or requires withholding certain limited information that falls under one or more of nine statutory exemptions (5 U.S.C. §§ 552(b)(1-9)). Section (b) of the FOIA, which contains the

FOIA's nine statutory exemptions, also directs agencies to release to FOIA requesters any reasonably segregable, non-exempt, information that is contained in those records.

Exemption 6

Exemption 6 serves to protect Personally Identifiable Information (PII) contained in agency records when no overriding public interest in the information exists. BPA does not find an overriding public interest in a release of the information redacted under Exemption 6—specifically, employee ID numbers. This information sheds no light on the executive functions of the agency and we find no overriding public interest in its release. BPA cannot waive these redactions, as the protections afforded by Exemption 6 belong to individuals and not to the agency.

As required by 5 U.S.C. § 552(a)(8)(A), information has been withheld only in instances where (1) disclosure is prohibited by law or (2) BPA foresees that disclosure would harm an interest protected by the exemption cited in the record. When full disclosure of a record is not possible, the law further requires that BPA take reasonable steps to segregate and release nonexempt information. We have determined that in certain instances partial disclosure is possible, and have accordingly segregated the records into exempt and non-exempt portions.

Fees

There are no fees associated with the processing of your FOIA request.

Certification

Pursuant to 10 C.F.R. § 1004.7(b)(2), I am the individual responsible for the records search, redactions, and information release described above. Your FOIA request BPA-2021-00608-F is now closed with the responsive agency information provided.

Appeal

The adequacy of the search may be appealed within 90 calendar days from your receipt of this letter pursuant to 10 C.F.R. § 1004.8. Appeals should be addressed to:

The written appeal, including the envelope, must clearly indicate that a FOIA appeal is being made. (The Office of Hearings and Appeals prefers to receive appeals by email.) The appeal must contain all the elements required by 10 C.F.R. § 1004.8, including a copy of the determination letter. Thereafter, judicial review will be available to you in the Federal District Court either (1) in the district where you reside, (2) where you have your principal place of business, (3) where DOE's records are situated, or (4) in the District of Columbia.
