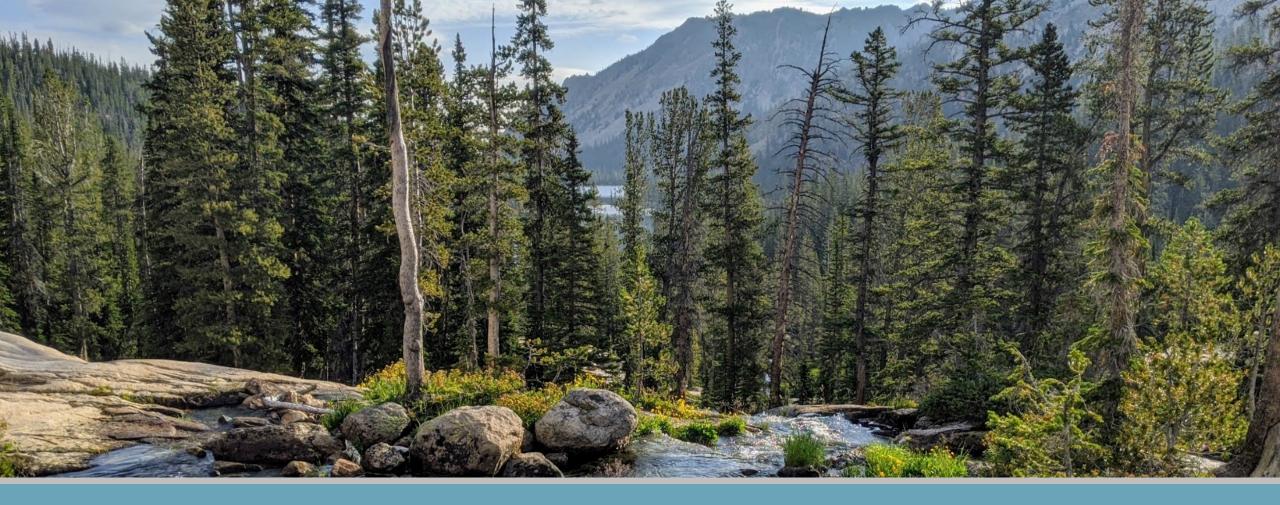


#### BONNEVILLE POWER ADMINISTRATION Workshop Norms & Expectations

#### **Section 5 Feedback**

- 1. 5.1.1 Slice Product Description Slice Output request for each Scheduling Hour in the next operating day submitted a day ahead.
  - BPA intends to retain this provision.
- 2. 5.1.1 BPA Operational Control of FCRPS.
  - BPA intends to retain this provision.
- 3. 5.1.3 Customer obligation to serve TRL in excess of Slice Output and Block amount.
  - BPA intends to retain this provision.
- 4. 5.1.5 Slice Product does not provide within-hour or within-day energy or capacity.
  - BPA intends to retain this provision.
- 5. 5.3 Slice Percentage in Second Year of Rate Period
  - BPA will propose a change to calculate Slice Percentage in each year of Rate Period
  - BPA will propose a timing change to calculate Slice Percentage and Net Requirements for both years of the Rate Period in the Above-CHWM process prior to each Rate Period

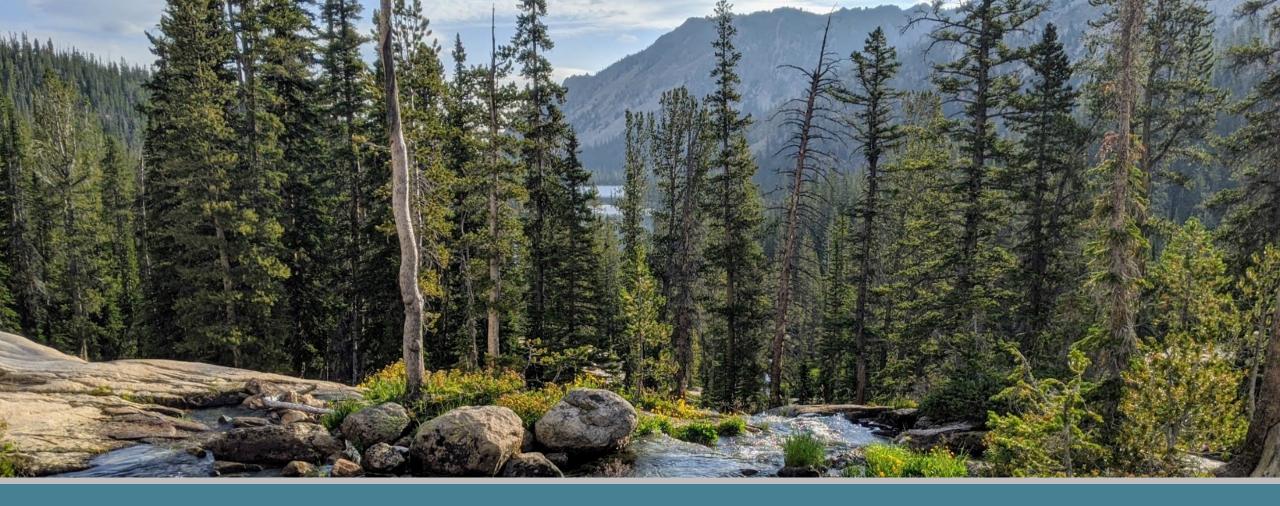
