The *ex parte* rule prohibits **BPA from discussing matters within the scope of a section 7(i)** proceeding, unless proper notice is given. For that reason, issues and arguments concerning the PRDM and tiered rates for the post-**2028 period should not be made in this meeting.** Please direct any such comments to PRDM-26, as described in the PRDM-26 Federal **Register Notice.**
