A. Overview

- <u>1. The Southern Intertie is comprised of the Northwest AC Intertie (NWACI) and the Pacific DC Intertie (PDCI).</u>
 - a. The NWACI and PDCI are included in the Western Electricity Coordinating Council (WECC) path rating catalogue.
- 1. BPA performs System Impact Studies, System Facilities Studies, and/or Cluster Studies for Long-Term Firm (LTF) Transmission Service Requests (TSRs) when there is insufficient capacity to award service without a transmission system upgrade, except as noted below for the Southern Intertie.
 - For information on how BPA performs studies for LTF TSRs impacting the BPA Network refer to the TSR Study and Expansion Process (TSEP) Business Practice.
- BPA will perform sStudies to increase capacity on the Southern Intertie are performed at either its BPA's discretion or upon Customer request as described below.

- 3. The studies performed by BPA will be a combination of the following as necessary:
 - a. System Impact Studies.
 - b. System Facilities Studies.
 - c. Cluster Studies.
 - d. WECC path rating increase studies.
 - 3.i. WECC path rating increase studies are required for If a LTF TSR requires a transmission system upgrade that will necessitate a rating increase of a paths included in the Western Electricity Coordinating Council (WECC) path rating catalogue₇.
 - ii. Transmission Provider(s) at both ends of the intertie <u>and any impacted</u> <u>capacity owners and facility owners</u> must agree to participate in the WECC study process.
 - a.<u>iii.</u> The Customer will be required to advance fund the WECC study process as well as <u>coordinate</u> any other required agreements to maintain a valid completed application.
- <u>These additional studies may be able to be BPA may performed WECC studies</u> at the same time as the System Facilities Study.
- b.5. These studies will take a minimum of 12 to 18 months.
- 6. BPA will use due diligence to perform studies per the tariff_OATT prescribed timelines, however, studies must be coordinated with all impacted third party Transmission Providers and this will likely may result in delays that are outside of BPA's control.

B. Southern IntertieCustomer Requested Study Process

- 1. The Southern Intertie is comprised of the Northwest AC Intertie and the Pacific DC Intertie.
- 2.1.Customers may request a study of any of the Customer's LTF TSR(s) in STUDY status on OASIS which impact the Southern Intertie.
- a.2.A formal request stating the AREF(s) of the TSR(s) to be studied must be submitted via email to the Customer's assigned Transmission Account Executive
- b.3. Upon receipt of the Customer's formal request, BPA will:
 - i<u>.a.</u> Post a notice on OASIS that a study request has been submitted and a Cluster Study on the Southern Intertie may be performed<u>:- and</u>
 - ii.b. Tender a study agreement to the requesting Customer requesting a study (requesting Customer) within 30 Business Days. This study agreement will define the requesting Customer's obligations to perform third party coordination with all impacted Transmission Providers and capacity or facility owners.
 - a.<u>i.</u> If the requesting Customer fails to execute and fund the study agreement within 15 Calendar Days, including provision of a <u>dData eExhibit</u> if BPA requests additional information, and meet the third party coordination requirements defined in the study agreement, if applicable, within

60 Calendar Days, their TSR(s) will be DECLINED and <u>receive no further</u> <u>consideration removed from BPA's LTF pending queue</u>.

- **b**.<u>ii</u> If the requesting Customer executes and funds the study agreement, and meets the third party coordination requirements, their TSR(s) will be considered eligible for an intertie study.
- c.4. Once the requesting Customer has met the third party coordination requirements and appropriate third parties have agreed to participate in the study, BPA will tender a study agreement to the following Customers with LTF TSRs in STUDY status impacting the same portion of the Southern Intertie (either the <u>NWACI_Northwest AC Intertie</u> or the <u>PDCI_Pacific DC Intertie</u>):
 - i.a. LTF TSRs submitted prior to that of the <u>requesting</u> Customer <u>requesting a study</u>; and
 - ii.b. LTF TSRs submitted after that of the <u>requesting</u> Customer requesting a study which BPA determines on a case-by-case basis will ensure the most efficient use of study resources.
 - iii.i.Customers included in the study (Aaffected Customers) will not be obligated to perform third party coordination, as the requesting Customer will be required to conduct the necessary coordination.
 - iv.ii.Affected Customers will <u>either be required to execute</u> and fund the study agreement, including provision of a <u>dD</u>ata <u>eE</u>xhibit if BPA requests additional information, or <u>have</u> their TSR(s) <u>will be</u> DECLINED and <u>receive no further consideration removed from BPA's LTF pending queue</u>.

d.<u>5.</u>At the conclusion of a study:

- i.a. If the requesting Customer elects not to proceed to the next phase, the study effort shall be terminated, the requesting Customer's TSR(s) will be DECLINED and receive no further consideration, and any affected Customers will retain their queue position-; or
- ii.b. If the requesting Customer executes the next phase agreement, all affected Customers will receive an agreement as well. If the study agreement is not executed <u>by an affected Customer</u>, the<u>ir</u> TSR(s) will be DECLINED and <u>receive</u> <u>no further consideration removed from BPA's LTF pending queue</u>.

C. BPA Initiated Study Process

- 3.1.If a study (described above) will be performed at BPA's discretion, BPA will post a notice on OASIS and tender a study agreement to Customers with LTF TSRs in STUDY status impacting that the applicable portion of the Southern Intertie (NWACI or PDCI).
 - a. Affected Customers will not be obligated to perform third party coordination, as BPA will conduct the necessary coordination.
 - b. Affected Customers will <u>either be required to execute</u> and fund the study agreement, including provision of a <u>dD</u>ata <u>eE</u>xhibit if BPA requests additional information, or <u>have</u> their TSR(s) <u>will be</u> DECLINED and <u>receive no further</u> <u>consideration removed from the LTF pending queue</u>.

4. BPA will use due diligence to perform studies per the tariff prescribed timelines, however, studies must be coordinated with all impacted third party Transmission Providers and this will likely result in delays that are outside of BPA's control.
