Curtailment Priority

- 1. Curtailments are processed *pro rata* in ascending numerical order. Schedules in each E-Tag Priority are curtailed to zero before moving to the next E-Tag Priority.
 - All Transmission Service Products within each E-Tag Priority are curtailed pro rata or redispatched as a group within the E-Tag Priority.¹
 - For example, BPA curtails all the contributing 1-NS schedules by 100% before moving to 2-NH schedules (if relief is still projected to be needed after curtailing all the 1-NS)
 - 6-CF (i.e. Conditional Firm schedules that are not firmed-up) and 6-NN share the same curtailment priority.
- 2. If relief is still needed after curtailing E-Tag Priorities 0-6, then:
 - "BPA Transmission Services will curtail E-Tag Priority 7-F schedules and order generating facilities that have an obligation to redispatch at the request of BPA Transmission Services under Section 33 of the OATT to provide NT Redispatch on a pro-rata basis if the overload persists. BPA Transmission Services will curtail E-Tag Priority 7-F schedules in proportion to the 7-F flow on the affected Managed Path* and request NT Redispatch in proportion to the scheduled 7-FN and unscheduled firm NT flow on the affected Managed Path." [Redispatch and Curtailment Procedures BP D.5.]
 - That is to say, if NT service is contributing to 15% of the flow, then the redispatch obligation will be 15% of the remaining relief and the scheduled 7-F PTP will be curtailed to provide the remaining 85%.
 - o If BPA does not have NT Redispatch resources that can provide the required relief, then curtailment and resupply of 7-FN schedules can be implemented. For example, NT service across an external path.
